### POWER TO VOTE -PROXY VOTE- IN GENERAL REPRESENTATION

Criteria for the presentation of the Power to Vote (Proxy) to the ALDOO General Assembly

- The ALDOO member Association with voting rights, if they can not be represented by its Chairman, may designate a representative through the submission of this form.
- The person assigned is entitled to vote on all proposed items on the agenda of the Assembly or just those that are specified by the association member
- The association must send this Power of Representation 1 month before the Assembly and will be enabled for receipt of this form by the end the following week, therefore the name of each representative with voting rights will be established 3 weeks before the General Assembly.
- This form must be signed in original copy by the Board of Directors of the ALDOO member Association. (an original signed and scanned and forwarded as attachment will be acceptable)
- If the President of the Association member was unable to attend the Assembly and had not presented this form within the required time frame, the ALDOO member Association will be without ALDOO representation to exercise their right to vote.
